



**LEANNA HICKS PUBLIC LIBRARY (INKSTER PUBLIC LIBRARY)  
DVD/VIDEO CONTRACT FOR BORROWERS UNDER AGE 18**

**BORROWERS WITH A DVD/VIDEO CONTRACT SIGNED BY THEIR PARENT OR LEGAL GUARDIAN WILL HAVE ACCESS TO ANY AND ALL VIDEOS IN THE LIBRARY'S COLLECTION, REGARDLESS OF THE VIDEO'S RATINGS.**

1. This contract may be subject to change without notice and can be unilaterally revoked by the Inkster Library Board at any time. In addition, the DVD/Video Policy may be subject to change without notice.
2. To borrow a VHS, DVD or other video-type formats, you must have a valid library card in good standing from the Inkster Public Library or from a member library within The Library Network or have a MLibraryCard. You must *also* have this DVD/Video Contract signed by a parent or legal guardian. The parent or legal guardian must be present at the Library at the time of signing.
3. It is the parent's or legal guardian's responsibility to read this contract and the DVD/Video Policy and ensure the minor is abiding by both. Once the minor turns the age of 18 then he/she will be solely responsible for any violations he/she commits as an adult and the parents or legal guardians will be absolved from any actions of the former minor. This contract will become null and void; however, the parents or legal guardians will still be responsible for any violations committed prior to the minor turning 18 years old.
4. If you have problems viewing a video, you should check your television and video media player to make sure the adjustments are set correctly. If you still have problems, please notify a Library staff member upon returning the video. **DO NOT ATTEMPT TO OPEN A VHS VIDEO CASSETTE OR ATTEMPT TO REPAIR A VHS, DVD, OR OTHER VIDEO FORMATS.**
5. To avoid late fees, all videos must be returned prior to closing time on the due date. If the Library is closed on the date the video is due then it must be returned by 9:00 a.m. on the next business day. If a video is lost, damaged, or not returned to the Library within 21 days past the due date then there will be a fee for replacement costs which is an irreversible charge to the patron's account.
6. COPYRIGHT LAWS allow for videos to be viewed for private home-use only and prohibits any other use, copying, reproduction, or public performance.
7. FAILURE TO ADHERE TO THIS CONTRACT AND LIBRARY POLICIES MAY RESULT IN THE LOSS OF BORROWING PRIVILEGES.
